6. East Lothian Health and Social Care Partnership

Andrew and Jennifer shared a presentation with the community council. Andrew noted that they want input from the local communities as the needs and requirements differ per areas. The need the feedback from local Action

Margo asked whether they were able to provide us with a rough cost per capita (private care, at home care etc.) Andrew stated that they will have that information to share as it will be mapped out and modelled for the options analysis.

7. Scot Gov Funding

It was noted that ELC is the 3^{rd} lowest funded council in Scotland but is the 2^{nd} fastest growing.

George stated that he feels that the formula Scot Gov uses needs to be changed.

John noted that ELC is looking at delaying capital expenditure.

John touched on the RAAC issues at Preston Lodge and Brunton hall and noted that the issue at PL is easier to solve than that at the Brunton. He further noted that ELC has a 30 - 40% janitorial absence rate, which means that facilities such as libraries etc. cannot be serviced, as they need the staff at the schools.

John said that there was very good, robust questioning of the financial team at the last council meeting and the papers are available to be viewed by the public.

Frank queried the 5-week closure of a mile long section of the B6368 for roadworks. John stated that he has raised the question but hasn't received an answer yet.
