2. Disclosure of Interests

3. Approval of previous minutes and action update

The minutes were approved.

Actions:

IG noted that he had reached out to Nicola McDowell. He noted that any communications are likely to be issued to the school first. RG indicated that they were hoping to get a representative to attend the parent council meeting.

SaA queried what the maintenance programme was for the school while mothballed.

CM stated that they had not had any responses from Education as regards their questions around mothballing. She noted that they had also raised the question of what is to be done with the items inside the school that has been paid for by the PTA over the years. CM further noted that going according to the council timeline, the school would be closed in March 2026, so the building will be empty for 18months. IG will follow up with Nicola as regards the maintenance program, building security and the timeline for the closure of the school.

CM said that the PTA would continue hosting the annual events as usual. The looked into the constitution and confirmed that they are allowed to use the PTA funds for events geared to the youth and community.

MH suggested making it a part of the community fund and opening it up to the community to assist with the events. IG - follow up with NM

4. Finance

MH shared the finance report ahead of the meeting. She noted that we have received the LPS grant of £2274. This is down from the £2351 that we received last year.

She noted that the audit of the accounts is currently ongoing.

5. Road Conditions in Humbie

MH noted that we have a major issue with potholes in the area. The road up to the Church is in a very poor condition. The congregation complained and 4 potholes have been filled.

Humbie contributes a large amount to the council, we need the potholes repaired.

IG will share the pothole reporting process and link on the website. MH will draft an email to be sent through to the Council.

GM indicated that he will be meeting with the roads team and will raise it with them.

SW stated that the Council faces risks of litigation if they don't deal with the potholes.

GM noted that if a vehicle is damaged due to a pothole that the Council is aware of, the Council is liable to pay the costs involved with damages/repair.

6. Update - Community Interest in East Saltoun Kirk

IG noted that the architect working for the estate had shared some options. IG has now spoken to an independent firm, and they will assist with outlining a feasibility plan. How much would it cost to make the kirk usable? Once we hear back from the surveyor, we can see what we want to do at that point.
